Sponsor youth programs for firearm training

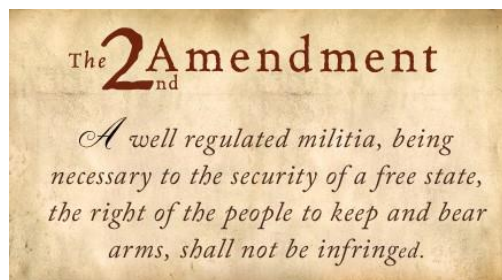
